

Not illustrated. 1898 Excerpt: .Board of Direction shall meet within twenty days after the Annual Meeting, and shall then appoint from its members a Finance Committee of five, a Library Committee of five, and a Committee on Publications of five. At least three members of the Finance Committee, and two members of the other Committees, shall be resident within fifty miles of New York. These Committees shall report to the Board of Direction, and perform their duties under its supervision. 8.--The Finance Committee shall have immediate supervision of the accounts and financial affairs of the Society; shall employ an expert accountant to audit the accounts monthly; shall approve all bills before payment, and shall make recommendations to the Board of Direction as to the investment of moneys, and as to other financial matters. 9.--The Library Committee shall have general supervision of the Library and the House of the Society and the property therein; shall make recommendations to the Board with reference thereto, and shall direct the expenditure for books and other articles of permanent value, of such sums as may be appropriated for these purposes. 10.--The Committee on Publications shall have general supervision of the publications of the Society, and of contracts and expenditures connected therewith. 11.--In the consideration of papers offered for presentation, those papers containing matter readily found elsewhere, those specially advocating personal interests, those carelessly prepared or controverting established facts, and those purely speculative or foreign to the purposes of the Society, shall be rejected.
